Kara Marchione, Education Policy Director Ranking Member Patty Murray, D-WA

Kara Marchione is the Education Policy Director, U.S. Senate Committee on Health, Education, Labor and Pensions (HELP). She manages the education, human services and workforce portfolio for the HELP Committee under Ranking Member Patty Murray (D-WA). Prior to her position on the Committee, Ms. Marchione was a Senior Vice President at Penn Hill Group, focusing on a wide range of issues including early education, K-12 education and higher education. Before joining Penn Hill Group, Ms. Marchione was a senior education policy adviser for the U.S. House Committee on Education and the Workforce. She also spent three years as legislative director for Rep. Dave Loebsack (D-IA). In addition, Ms. Marchione spent seven years working in the personal office of the late Sen. Edward M. Kennedy and as a policy adviser for Sen. Kennedy on the U.S. Senate Health, Education, Labor, and Pensions Committee. Ms. Marchione has a bachelor's degree in communications, law, economics and government from American University in Washington, DC.

Jacque Chevalier Mosely, Director of Education Policy Chair Bobby Scott, D-VA

Jacque Chevalier Mosely serves as the Director of Education Policy for Committee on Education and Labor of the U.S. House of Representatives under the leadership of Chairman Robert C. "Bobby" Scott (D-VA). As director she oversees the Committee's education and child welfare portfolio, spanning jurisdiction of the Subcommittees on Early Childhood, Elementary, and Secondary Education; Higher Education and Workforce Investment; and Civil Rights and Human Services. Prior to her current position, Jacque served the Committee in various roles, including lead policy staff and negotiator for the 2015 reauthorization of the Elementary and Secondary Education Act (ESEA). Jacque first came to the Committee under the leadership of Rep. George Miller (D-CA), now retired, during which time she served as lead policy staff and negotiator for amendments to the Rehabilitation Act of 1973 to reauthorize federal disability employment programs (Title IV of the Workforce Innovation and Opportunity Act of 2014). Jacque's areas of expertise include budget and appropriations, Title I-A of the ESEA, civil rights in education, and school choice. Before coming to Congress, Chevalier Mosely worked in federal education policy roles with leading national nonprofits, including the National PTA and United Way. Jacque graduated with high distinction from the University of Virginia and resides on Capitol Hill with her husband and cat, Truman Catpote.
